YOU ARE RESPONSIBLE for all parking fees and violation fines incurred while conducting court business.

YOUR RIGHTS: You have many legal rights, including: to be informed of the nature of the charges against you, to remain silent; any statement you make can and will be used against you. To consult and be represented by an attorney. If you cannot afford one, you have the right to request one be appointed for you. To deny the allegation by appearing and pleading not guilty and to have a hearing before a judge or, in some cases, a jury, during which the People would have to prove your guilt beyond a reasonable doubt. If you have a trial, the right to subpoena (free of charge) and question witnesses, present evidence and to testify or choose not to testify on your own behalf. If you are convicted, the right to appeal the outcome to a higher court, provided certain filing deadlines and costs are met.

APPEARANCES: You must appear in court on the date and time indicated on your ticket unless the officer wrote a payment amount on the front and we have received your payment in full before your court date. **IF YOU ARE LESS THAN 18, your parent or guardian must also appear in court with you and accompany you to conduct any business in court support offices.**

TO CHANGE A COURT DATE YOU MUST APPEAR IN PERSON at 224 E. Kiowa in Room 108 before the court date indicated on the front of this summons. Don't call or write the court asking to change your appearance date. If you are less than age 18 your parent or guardian must also appear with you. Please bring this copy of the summons with you.

TO PAY YOUR SUMMONS INSTEAD OF APPEARING:

- Payment in full MUST be received BEFORE your court date.
- Include this summons when making payment.
- Juveniles: A parent must sign this summons for payment to be accepted.
Municipal Court accepts the following credit cards: Visa, MasterCard and Discover.

- 1) **PHONE:** To pay by credit card over the phone Call (719) 385-5999. DO NOT hang up until you get a receipt number.
- 2) **INTERNET:** Log on to www.springsgov.com/Departments/MunicipalCourt
- 3) **MAIL:** Make your check payable to: CITY OF COLORADO SPRINGS and mail to the address indicated above. Include this summons.
- 4) **IN PERSON:** Between 8:00AM and 4:30PM at the Municipal courthouse. Bring this summons.
- 5) **DROP BOX:** Place this summons along with your payment in an envelope and place in the drop box in front of the Municipal courthouse. DO NOT place in drop box ON your court date as it will not be processed until the following day and a warrant may be issued.

YOU ARE RESPONSIBLE for having your payment received on time by the court.

CONSEQUENCES: By paying the fine instead of coming to court, you give up all your legal rights and you plead guilty to the offense(s) charged. Penalty points may be assessed against your driving record by DMV. **IF YOU DO NOT WISH TO PLEAD GUILTY, DO NOT PAY THE FINE.** Come to court. Expect to spend about 2-3 hours in court. Court Costs (currently \$25) are applied to all payments made on or after the court date. Additional fees may be assessed if your check is returned by the bank (bad check fees may be deducted electronically from your account), or if you fail to appear in court, or if you fail to pay this summons. Failure to appear in court may result in a bench warrant for your arrest and you could be taken into custody at any time. An outstanding warrant may impair your ability to obtain or renew a Colorado driver's license, or may also result in its revocation. If you currently have an outstanding warrant for your arrest, your payment may be returned and you may be required to appear in court as directed on the front of this summons.

A defendant may petition the district court of the district in which any conviction records pertaining to the defendant for a petty offense or municipal violation are located for the sealing of the conviction records. Refer to CRS 24-72-308.9 for more information.

If you are not a citizen of the U.S., you are advised that conviction of the offense for which you have been charged may have the consequences of deportation, exclusion from admission to the U.S., or denial of naturalization pursuant to the laws of the U.S. Consulting with an attorney is recommended prior to entering a plea of guilty or nolo contendere in this court.

COMPULSORY INSURANCE CHARGES

If you have been charged with driving without insurance (city ordinance 10.28.101), showing proof of vehicle ownership and that liability insurance was in effect at the time will make the court process faster and more efficient. **IF YOU HAD LIABILITY INSURANCE** in effect for the vehicle you were driving on the date and time you were ticketed, either fax (719) 385-6437 or mail to the court 1) a copy of this ticket, 2) a copy of your Certificate of Insurance, 3) a copy of your registration and 4) your name and phone number within 10 days of receipt of this ticket OR before your court date, bring these documents to the Court Referee in Room 107, (9:00AM- 12:00PM and 1:00PM-4:00PM Monday through Friday). **IF YOU DO NOT RECEIVE A RESPONSE**, come to court on your court date. Resolution on the Compulsory Insurance charge does not resolve any other charge(s) on your summons.

PAYMENT OF ALL FINES, FEES AND COSTS IS DUE IN FULL WHEN YOU ARE SENTENCED
ADDITIONAL COSTS MAY BE INCURRED IF PAYMENT IS DELINQUENT.
